S.R.O. 108(KE)/2015:

In exercise of the powers conferred by section 14 of the Pakistan Standards and Quality Control Authority Act, 1996 (VI of 1996), the Federal Government in consultation with the Pakistan Standards and Quality Control Authority, is pleased to,—

- (a) prohibit the manufacture, keeping in stock and the sale of the articles specified in column (2) of the Schedule below which do not conform to the Pakistan Standards; and
- (b) direct that every such article which conforms to the Pakistan Standard shall be marked with the Standard mark of the Authority specified in column (3) of the Schedule below namely:—
